CHAPTER 4-6

ARTICLE G. TAXICABS

4-6G-1: DEFINITIONS:

- DRIVER:** When used in this Chapter shall include every person in charge of or operating any taxicab as herein defined, either as agent, employee or otherwise.
- OWNER:** When used in this chapter shall be construed to mean any person, firm or corporation who has the bona fide legal title or control, direction, operation, maintenance, leasing or the collection of revenues deriving from such taxicabs so operated for hire on the streets in the City.
- TAXICAB:** As used in this Chapter means all motor vehicles propelled and operated for passenger hire, including limousines, and except motor buses running and operating on established routes, sight-seeing buses, charter buses, and funeral vehicles.

4-6G-2: TAXICAB LICENSE:

No owner or driver shall operate any taxicab without first having obtained a license therefor.

4-6G-3: APPLICATION FOR LICENSE:

Any person desiring a license for any taxicab shall:

- (A) File an application with the Business Regulatory Officer on a form provided for that purpose setting forth the name, business and residence address of the applicant, full description of the motor vehicle for which a license is desired, and the registration plate of such motor vehicle as set forth in chapter 951/2, section 3-412(e), Illinois Revised statutes, as amended from time to time;
- (B) File with the Business Regulatory Officer a proof of financial responsibility as set forth in chapter 951/2, section 8-101, et seq. Illinois Revised Statutes, as amended from time to time;
- (C) Submit to the Business Regulatory Officer with the application, a taxicab license regulatory fee in the amount of fifty dollars (\$50.00), per vehicle requested to be licensed; said fee shall be refundable if a license is not granted.
- (D) Taxicab licenses issued under this Chapter shall not be assignable unless the proposed assignee shall first file with the Business Regulatory Officer the information required by this section;
- (E) Taxicab licenses issued shall run from one year of the date of issuance and may be renewed upon the payment of a new yearly regulatory fee, and proof of proper registration and financial responsibility as set forth above

4-6G-4: MARKINGS:

Each and every taxicab which may be licensed under this Chapter, and operated in the City, shall exhibit the license issued in a conspicuous place inside the vehicle.

4-6G-5: RATES:

Each and every taxicab licensed under this Chapter and operated in the City shall post inside the vehicle at a location visible to passenger(s) the rates of fare being charged.

4-6G-6: DRIVER'S LICENSE:

No person shall operate and drive a taxicab unless he has a valid driver's license as prescribed in chapter 951/2, section 6-1000, et seq, Illinois Revised Statutes, as amended from time to time.

4-6G-7: TAXICAB SAFETY:

No taxicab shall be operated in the City unless it is equipped with proper brakes, lights, tires, horn, muffler, rear vision mirror, and windshield wipers in good condition.

4-6G-8: REVOCATION:

The Mayor of the City is hereby empowered and authorized to remove or suspend the license of any taxicab found not to be safe or not in good condition, and the Mayor may revoke any license issued under the provisions of this Chapter, for failure on the part of the owner, operator, driver, lessee or licensee to comply with any provision or traffic regulations at any particular time in force in the City. In the event of the suspension or revocation of a license, no refund shall be made to the person to whom said license was issued for any portion of the license fee previously paid.
