- The soliciting agency shall carry liability insurance in the minimum amount of \$1,000,000.00 covering soliciting agency and City of Alton, Illinois, as co-insured and will file a certified copy of said insurance policy with the City Treasurer
- SUBMIT PERMIT FEE OF \$25.00

8-4-7: SOLICITING:

Soliciting contributions from the occupant of any vehicle shall be allowed in the city, subject to the following terms and conditions:

- A. Only at intersections where all traffic is required to come to a full stop;
- B. The soliciting agency must be registered with the attorney general as a charitable organization as provided by "an act to regulate solicitation and collection of funds for charitable purposes, providing for violations thereof, and making an appropriation therefor", approved July 26, 1963, as amended;
- C. The soliciting agency must be engaged in a statewide fundraising activity;
- D. The soliciting agency shall be liable for any injuries to any person or property during the solicitation which is causally related to an act of ordinary negligence of the soliciting agent;
- E. Any person engaged in the act of solicitation shall be sixteen (16) years of age or more and shall be wearing a high visibility vest;
- F. The soliciting agency will also fully indemnify the city from any claims, injuries, expenses or judgments that may arise from the solicitation activity; (Ord. 5808, 8-25-1993)
- G. The soliciting agency shall carry liability insurance in the minimum amount of one million dollars (\$1,000,000.00) covering soliciting agency and naming the city of Alton as an additional insured and the soliciting agency shall file a certified copy of said insurance policy with the city treasurer; (Ord. 6682, 10-23-2002)
- H. The soliciting agency shall pay a twenty five dollar (\$25.00) permit fee to the city treasurer for each fundraising activity which is contemplated. (Ord. 5808, 8-25-1993)
